

Aircraft Parking Request Procedures

- All Diversions (leased/non-leased space)
 - Scheduled aircraft (non-leased space)

All inbound diversions must be reported to RIC Airport Operations whether they will be parking at a leased gate, non-leased gate, or hardstand parking spot. Parking requests outside of a leasehold must also be coordinated with Airport Operations. The information contained in Appendix E details current airline gate lease status and hardstand parking positions on various ramps. This information is subject to change due to factors like new and changed lease obligations, construction, maintenance, emergencies, and VIP operations.

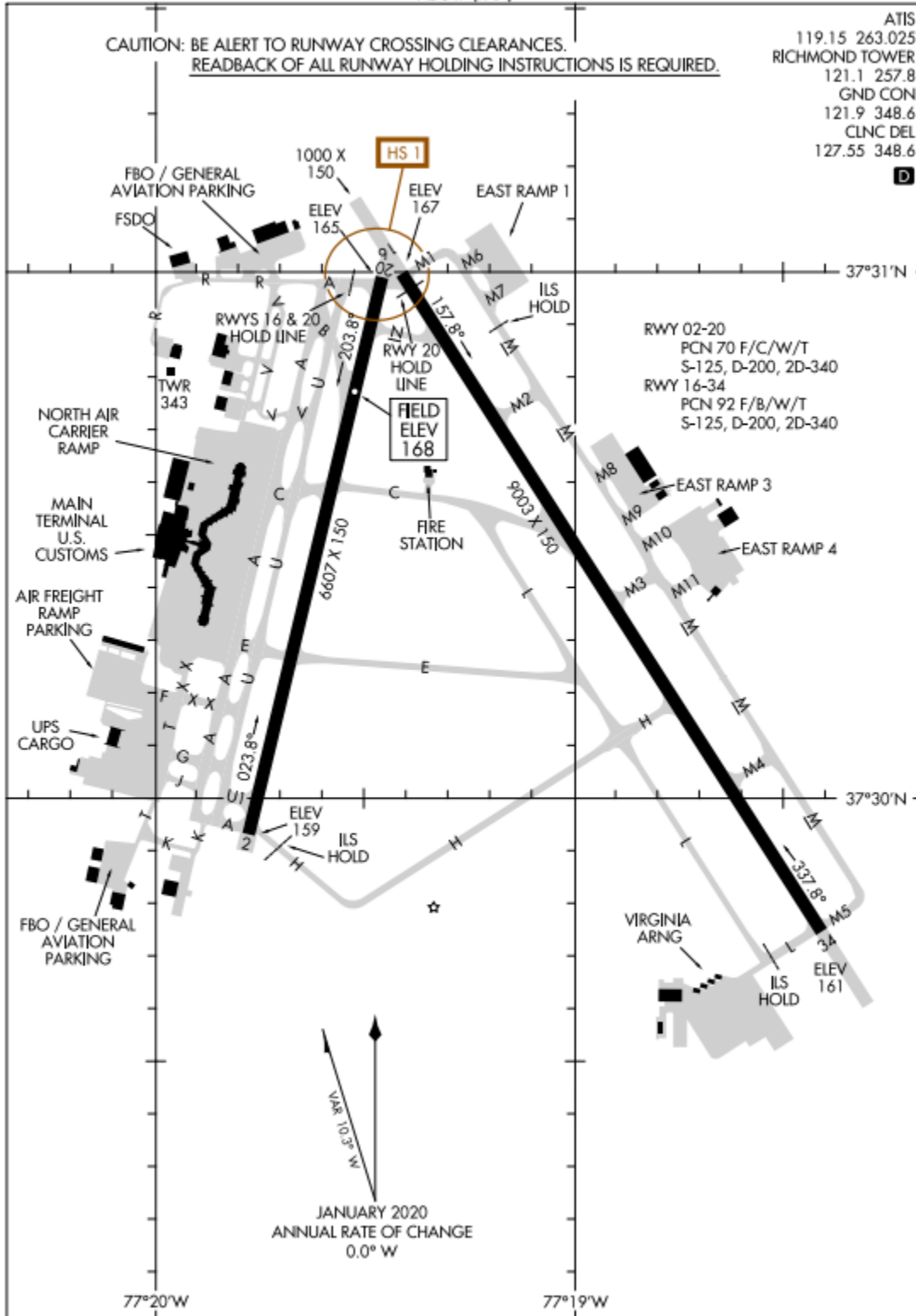
