  - Bubble Cited as United Boeing 737 Engine Fire Cause.
  - Tire flies off United Boeing plane shortly after take-off.
  - American Airlines 777 clips frontier A321 in Miami.
  - United Airlines Flight rolls off runway at Houston.
  - Boeing 737 loses external panel mid-flight, lands safely in Oregon.
  - Incident on Latam Flight Injures dozens aboard Boeing 787.

## • RIC Safe

- Local Incidents and Initiatives.
  - A speeding tug in the North Bagroom damaged the south roll-up door by driving into the frame. No injuries, but one pedestrian was almost struck. Door is out of service and open.



 A fuel truck struck a parked fuel truck. Driver reported being distracted before the accident.



- In Virginia it is against the law to use a handheld device while driving.
  - The CDC has identified 3 different kinds of Distracted driving.
  - Visual distractions that cause you to take your eyes away from the road.

- Manual distractions that cause you to remove your hand from the wheel.
- o Cognitive distractions that take your mind off of driving.
- About 3,000 people die in auto incidents a year due to distracted driving.
- Taking your eyes off the road for 5 seconds at 55mph is the equivalent to traveling the length of a football field without looking.

  - High winds blow a bag cart into aircraft at Peoria. Leading to flight cancellation.
  - At least 50 people arrested after protests disrupt traffic in loop, near O'Hare airport.
