When the traveler claimed she was traveling with someone else and attempted to distract, CeAsia and Yota followed up with additional questions, ultimately calling Airport Police. Their efforts and diligence helped avoid a significant security incident and protected the passengers on that flight.

### **Switchgear Replacement Project Continues**

RIC's Maintenance division has shared a work schedule for the ongoing switchgear replacement project that is resulting in temporary, isolated power outages that are having an impact on the facility and some systems. The vast majority of the work is being planned during the late night to reduce disruption to terminal activities. Additional outages will be scheduled in the future; please stay tuned for more details regarding this ongoing project.

Please take careful note of the schedule you received via email from Dereck Tingfah, particularly the dates of 4/14 & 4/15, as well as 4/18 & 4/19. Airport Maintenance recommends that jetways be removed from aircraft prior to power shutdown on April 15 and April 19 since the boarding bridge power will be out and systems like the auto level device will be inoperative.

It will be critical for airline operations to notify Airport Maintenance of any flight delays or disruptions on the evenings of the 14th and 18th, as well as the early morning hours of the 15th and 19th.
